
Progress Report of RSPG SG Long-term vision for the upper 6 GHz band

Since the RSPG#65 plenary meeting held on 13 November 2024, the Subgroup has met twice, in a hybrid session 3 December 2024 at the EC premises in Brussels and a virtual session on 21 January 2025. Representatives from numerous countries are participating in the work activities of the group:

AT, BE, CY, CZ, DE, DK, EL, ES, FI, FR, HR, HU, IE, IT, LIE, LU, MNG, MT, NL, NO, PL, PT, SE, SI, TR, UA, and the European Commission & ECO.

1) Based on the adopted plan:

the subgroup continued its work. It invited Mr. Abu Hamed Md Ismail, Chairman of CG ECC PT1 for the upper 6 GHz band, to be informed on the latest developments on the subject in the CEPT.

- 2) The co-chairs met with representatives of BEREC open roaming – offloading on 17. January 2025. BEREC does not have this WI in program for 2025. Some work may be triggered based on Working arrangement between BEREC and RSPG.
- 3) Following the RSPG#65 plenary meeting, the subgroup continued discussion on MS feedback on questionnaire's open issues, feedback on RAS protection, spectrum demand, policy options, status FS protection (Italian study Based on the document from Germany – options for the upper 6-GHz band – the group concluded, that the UWB applications has no entitlement to protection, but should be taken into consideration.
- 4) The subgroup developed further on the evaluation matrix. Member States have provided the first feedback on the evaluation matrix. Matrix is a good tool for internal use for Member States. Some improvements will be made for the next meeting, and it will be further discussed if and how the subgroup may use it.
- 5) DE, ES, FI, FR, PT, SE, and SI contributed to developing of Policy Options. To the last compiled version Sweden proposed some modifications. The subgroup will continue working on the document.
- 6) The next meeting will be online, and the date will be decided by correspondence.
