RSPG work item: update to Plenary				
Work item	5G Implementation Challenges			
Rapporteur/s	Bo Andersson, PTS, Sweden, Tassos Lyratzis, EETT, Greece			
Rationale	The European Commission presented in September 2016 an Action Plan for 5G in Europe to show that Europe has the ambition to lead on the deployment of 5G and move to a gigabit society and make sure all Europeans, whether in the countryside or in cities, can get access to a quality internet connection.			
	RSPG addressed initial spectrum strategy milestones on 5G in its Opinion of November 2016 and send a clear signal towards the global development of harmonised frequency bands above 24 GHz in its interim Opinion on WRC-19. Overall it is noted that the spectrum policy challenge on 5G is very closely related to the on-going development of 5G technology.			
	In consequence, RSPG will continue its efforts and contribute actively to the development of Europe's spectrum policy strategy regarding 5G, including bands being studied at WRC, and other spectrum needed to deliver the services to all European citizens including for IoT/M2M and other applications such as ITS.			
Scope	The RSPG has developed a strategic roadmap towards 5G for Europe and adopted a second opinion on 5G in February 2018 (supplementary opinior on strategic issues related to spectrum regulation of 5G networks).			
	On the basis of these, RSPG plans to present an analysis with a view on how to defragment the 3.4-3.8 GHz band in EU.			
	RPSG will assess the impact of the future use of 5G technology in other areas than mobile broadband (internet of things, intelligent transportation and other verticals) and initiate further work where necessary.			
	RSPG will engage to enable information and experience sharing in support of a successful roll-out of 5G in EU.			
Planned deliverables and timing	RSPG Opinion(s) or Report(s) as appropriate. High-level workshops could also be envisaged and used to facilitate these deliverables.

	Identify the challenges from a European perspective regarding what is necessary to do in order to launch and implement 5G on a large scale.			
	Analyse both on a policy level as well as on a level covering different spectrum bands and technologies.			

	Consider what applications and services European consumers will want to have to access to. Consider the use cases and future applications and services in demand from differend vertical industries in Europe. Assess possible constraints on these developments depending on the availability of different spectrum bands.
